### BY LAWS CHANGE PROPOSED

Our current By Laws require the Nominating Committee to be nominated at the October meeting, with Officer nominations made at the November meeting, then voted upon and installed at that same meeting. The KCRWC Board recommends changing the bylaws to allow the Nominating Committee and members more time to consider nominations for Office. Article VII, SECTION 1:

A. **Current:** A Nominating Committee of three (3) members shall be nominated at the September meeting.

**Proposed change:** June Meeting.

B. **Current:** Nominations may also be made from the floor following the report of the Nominating Committee at the November Meeting.

**Proposed Change:** October Meeting.
